The Mom Relaunch Program supports mothers re-entering the workforce by providing practical, hands-on experience through real-world projects, valuable networking opportunities, and training focused on soft skills and AI upskilling. A key focus is also supporting members in achieving a harmonious work-life balance. In 2025, the organization expanded its offerings by introducing the AI Readiness Program, which included Agentforce cohorts and an AI Infosession, delivered in partnership with the Tri-Valley Career Center and participation in the OpenAI Nonprofit AI Jam. 45 women participated in the program in 2025.

Mom Relaunch partners with Valley View Ventures to provide remunerated employment opportunities for program participants. These individuals are directly integrated into Valley View Ventures projects while maintaining employment with Mom Relaunch.

OTHER EMPLOYMENT PARTNERSHIPS: Mom Relaunch creates extra paid job opportunities for members through partnerships with various small businesses. These women are directly employed by Mom Relaunch, yet they contribute their work to partner organizations.
